

TOWN OF COUNTY LINE
Regular Meeting
July 13, 2020

I. Call to order

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on July 13, 2020 in the Town Hall. The invocation was given by Myrtle VanKleeck. The Pledge of Allegiance was recited by all.

II. Roll call

The roll call was had. The following persons were present: Mayor Arthur Self, councilor's Myrtle Van Kleeck, Eugene Kiley, John King , Steve Brewer and Brenda Lowe.

III. Approval of Minutes and Financials

The Minutes from the June regular meeting were read. Myrtle VanKleeck made the motion to accept them as read. Seconded by Brenda Lowe. Motion was unanimous.

The Financials for June were given. Steve Brewer made the motion to accept them as given. Eugene Kiley seconded. Motion was unanimous.

IV. Old Business

1. There is no change on Cobb Brazeel Road potholes. It appears to have had some mow/trim work.

2. The Parking Lot Perimeter Fence/Wire estimate was discussed. Brenda Lowe made the motion to accept the bid from Apple Fence for approximately \$1,470.00. Eugene Kiley seconded this motion. Motion was unanimous.
3. The update on ALAWEST vs. Mulvehill Lawsuit: Judge King had re-scheduled the hearing on the motion to dismiss County Line from the lawsuit for July 1, 2020, 9:30 AM at the Blount County Courthouse. We will continue to monitor this case.

New Business

1. Mayor Self reminded us that the Municipal election qualification ends on July 21, 2020 at 5pm CST. Town Hall will be open for candidate qualification Monday thru Friday 10:00 AM to 3:00 PM thru July 20, 2020. On July 21, 2020 Town Hall will be open 9:00 AM to 5:00 PM.
2. Mayor Self noted that he had signed a “COVID-19/CARES ACT SUBGRANT AGREEMENT” with Jefferson County for distribution of eligible expenses from the Cares Act. County Line was included in Jefferson County’s allotment from the Cares Act. County Line’s allotment was \$36,395 for unbudgeted, COVID-19 expenses expended between March 13,2020 and December 31, 2020.
3. A new Mobile Home Ordinance draft was passed out and discussed. This ordinance was tabled until the next meeting, giving the Council and Mayor the time to make any changes necessary.
4. Scott Mordecai asks if all the streetlights in the Town could be changed to LED. He felt that this could save money and give better lighting to the Town.
