## **County Line Town Meeting**

June 13, 2005 Time 7:10

Larry Calvert read the minutes of the previous meeting. Mayor Blackmon had 2 interjections: One concerning the petition from the citizens from Cobberzeel Rd. on the paving of the road, Second was requesting Larry Calvert to produce a copy of the letter stating the legal opinion on the water issue on Dean's Ferry. Mayor Blackmon also requested a copy of last council meeting minutes within 10 days. Larry Calvert made motion to accept. Mellany Piper seconded. Mayor Blackmon took a voice vote. Council voted to accept the minutes as read by Larry Calvert. Mayor Blackmon voted against. No financial report.

#### Town Business

Larry Calvert brought forth a complaint from Eric Reeves concerning town lawn vandalism. Someone threw rocks, nylon twine, roofing nails, and other debris on the town's property and a report was filed with the police department. The cost of repair for Mr. Reeve's lawn mower tires was \$250.70. Larry Calvert made a motion to replace the tires. Mellany Piper seconded. Motion carried unanimously. Larry Calvert made a motion to give Mr. Reeves a vote of confidence in the work he has performed for the town. Motion carried unanimously. Mayor Blackmon made a motion to rent from K&K Rental a metal detector for ½ a day to take care of lawn debris to be operated by Pam Sitton. Mellany Piper seconded. Motion carried unanimously. Bill Ivey introduced seconded reading of ordinance concerning the adoption of the International Building Code. Larry Calvert made motion to accept. Bill Ivey seconded. Motion carried. Mayor Blackmon abstained. Larry Calvert introduced seconded reading of banking ordinance on who is to sign checks, payment vouchers, or contracts for the Town of County Line. James Calvert made motion to accept. Mellany Piper seconded. Motion carried. Mayor Blackmon voted against. Larry Calvert stated the Cannon all in one printer would cost \$218.00 give or take some change with sales tax and \$199.00 give or take some change without sales tax. Bill Ivey made motion to purchase fireproof filing cabinet if has lock from Office Depot for \$769.99 plus tax. Motion carried unanimously. Larry Calvert made motion for A & A heating and air to install a heating and cooling system for \$3500.00 to be taken out of the capital gains and improvement fund. The system is to be installed to replace the air conditioner that was vandalized. There is a hole punched in the air conditioner that caused the compressor to burn up. A report was filed with the police department. Pam Sitton seconded. Motion carried. Mayor Blackmon abstained. Larry Calvert made a motion to pay all bills that are due. Motion carried unanimously. Larry Calvert made a motion to send a letter to WCA about the 4-way caution light at the intersection of Deans

Ferry/SmithMill Rd. that was pulled down. James Calvert seconded. Motion carried. Bill Ivey and Mayor Blackmon abstained. Mayor Blackmon states she will get in touch John Mulvehill to the status of the town's inspections and report at the next meeting. Discussion was held about the 666 Amendment to be followed up on. Larry Calvert made a motion to hire Jennifer Grooms for a 90-day trial period as the new town clerk. Mellany Piper seconded. Motion carried. Mayor Blackmon abstained.
