Monthly Meeting: July 10, 2006

1. A call to order.

The meeting was called to order by Mayor Sue Blackmon.

2. Roll Call.

Town Clerk Jennifer Grooms called roll.

Present - Mayor Sue Blackmon, Councilman Bill Ivey, Councilman Pam Sitton and Councilman James E. Smith.

Absent - Councilman James Calvert and Councilman Larry Calvert

Mayor Blackmon requested reason for previous month meeting cancellation. A discussion followed

3. a) Reading and approval of the minutes of the previous meeting.

Minutes of February 13, 2006 meeting were read by Town Clerk, Jennifer Grooms. Councilman Bill Ivey requested that the approval of the repair of the street light in front of Malcolm Calvert's be added. Councilman Bill Ivey called for a motion that the minutes be accepted with corrections. Councilman Pam Sitton seconded. Vote carried unanimously.

b)Reading and approval of the financial report.

The financial report of February, March, April, May, June was read by Town Clerk, Jennifer Grooms. Councilman Bill Ivey called for a motion that the financial report be accepted. Councilman James E. Smith seconded and the vote was carried unanimously.

4. Reports of committees.

Councilman Bill Ivey reported that he could not get answer on the sub station until after the election.

Mayor Sue Blackmon introduced the topic of paving the parking lot. A discussion followed. Councilman Bill Ivey moved to commit 7,000 to be paid out of the Road Fund to pave the parking lot contingent to a commitment from Councilperson Betty Fine Collins for 6,000 within the next thirty days. Councilperson James E. Smith seconded and

the vote was carried unanimously.

5. Report of officers.

Councilperson Pam Sitton asked if anyone had information on the issue of paving Cobb Breazeel Rd. Mayor Sue Blackmon stated that she had been in contact with Councilman Pitts. She stated that the estimate was for 12,000.00.

6. Reading of petitions, applications, complaints, appeals, communications, etc. Mayor Sue Blackmon introduced the issue of transferring the Mayor's mail to her house.

Mayor Sue Blackmon introduced the issue of the use of checks (\$1700) issued from the Mike Hale's (Sherriff of Jefferson County) office for public safety at the mayor's discretion. Mayor Blackmon suggested using the funds to purchase a radar gun. The gun will be used by Blount County but will remain the property of County Line. A town member suggested using any left over money to purchase radar warning signs. Councilperson Bill Ivey suggested placing a Property of the Town of County Line on the gun. No vote was taken due to the funds being the Mayor's discretion.

7. Resolutions, ordinances, orders, and other business.

Councilman Bill Ivey submitted his resignation. Councilperson Pam Sitton motioned to accept and Councilman James E. Smith seconded. Motion was carried unanimously.

Mayor Sue Blackmon declared the seat open.

8. Public comments.

Malcolm Calvert introduced the issues of:

- 1) the trailer park at Dean's Ferry and Cobb Brazeal Rd.
- 2) fire hydrants
- 3) and water for Jane

Councilperson Pam Sitton question the legality per comments from the League of Municipalities. Mayor Sue Blackmon motioned to extend the waterline to town limit for a commitment of 3,000 contingent of a letter of legality from the League of Municipalities. Councilperson Pam Sitton left before the meeting was adjourned due to comments made by a town member. Councilperson James E. Smith wanted to go on record saying that he would have no issue approving if the League deems the issue legal.

Mayor Sue Blackmon stated that she adjourns the meeting due to Councilperson Sitton leaving and no quorum.
