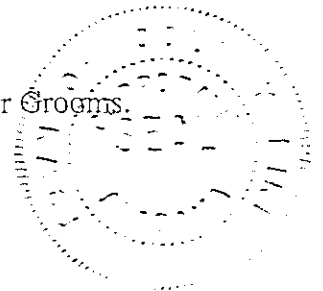

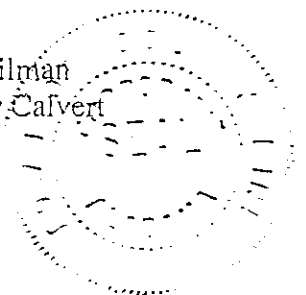
7. Resolutions, ordinances, orders, and other business.
