Minutes of April 20, 2010

Meeting was called to order at 7:05 PM by Mayor Calvert.

Roll was called with Mayor Calvert present; Council members present were Michael Calvert, Dennis Finch, Shannon Blackwell, Pam Sitton, and Ralph Calvert. A Quorum being present, meeting proceeded. Mayor Calvert stated this was a special meeting to discuss two topics, a proposed construction ordinance and a resolution.

Motion was made by Council Sitton and seconded to discuss the resolution concerning South Blount Grading LLC and their proposal to operate a solid waste facility within the Town Limits of County Line. Motion passed. Council Ralph Calvert moved to accept South Blount Grading's proposal as amended and read. Council Sitton seconded. With a roll-call vote Council Michael Calvert abstained, with Councils Ralph Calvert, Sitton, Finch and Blackwell and Mayor voting yes to pass the resolution. Motion and resolution passed. (Resolution is attached to these minutes.)


Ordinance 2010-02 was brought up (Building Permit Ordinance) for reading and discussion. Building Inspector John Mulvehill was present for consultation. The proposed ordinance was read by the clerk. Extensive discussion with the Building Inspector followed with suggestions and changes made. Motion was made to accept on first reading by Ralph Calvert, and seconded Roll Call vote to accept on first reading followed with Council Blackwell abstaining, Mayor Calvert voting aye, Councils Sitton, Ralph Calvert, Dennis Finch and Michael Calvert voting aye. Therefore ordinance will be tabled until next meeting for second reading, because vote was not unanimous.

Motion to adjourn was made by Council Michael Calvert and passed unanimously

RESOLUTION

WHEREAS, South Blount Grading, L.L.C. has informed the Town of County Line, Alabama, of its desire and intention to install and permit a solid waste disposal site (Construction, Demolition, Tire, Industrial, and Municipal Solid Waste) on the condition that all proper permits be obtained from the Alabama Department of Environmental Management and on the further condition that the Town of County Line be paid the sum of \$.50 per ton for waste and tires dumped at said site, and \$.50 per ton of coal mined from said property (a combination of fee and severance tax to equal \$.50), said amounts to be determined by certified scales on site; and rates per ton to be re-negotiated six (6) years after permit is issued.

WHEREAS, it is the intention of South Blount Grading, L.L.C. to utilize approximately 85 acres for the solid waste disposal site and to conduct or authorize mining operations on another approximately 100 acres of land; and,

WHEREAS, the Town of County Line is of the opinion that this proposed project would be beneficial to the citizens of the Town of County Line.

BE IT THEREFORE, RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF COUNTY LINE, ALABAMA, AS FOLLOWS:

That the Town of County Line, to the extent possible at this time, grants its permission and approval of said project, and states its intention to approve and recommend the approval of said site to the Alabama Department of Environmental Management, upon South Blount Grading, L.L.C., meeting all necessary conditions.

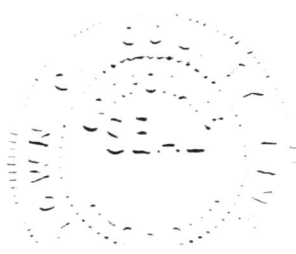
That the Town of County Line shall fully cooperate with South Blount Grading L.L.C. in the planning, permitting, and implementation of said solid waste disposal site.
