## **Minutes Town Council Meeting August 10, 2010**

Meeting called to order at 7:05PM by Mayor J.L. Calvert

Mayor asked Council Finch to open with a prayer.

After prayer, Roll was called with Mayor Calvert, Councils: Michael Calvert, Dennis Finch, and Pam Sitton present. Council Ralph Calvert absent. A Quorum being present, meeting proceeded.

Minutes of April 20, 2010 were read. Council Finch moved to accept w/corrections. Council Michael Calvert seconded. Motion was carried w/3 ayes and Council Pam Sitton abstaining.

Minutes of May 20, 2010 were read. Council Finch moved to accept w/corrections. Council Michael seconded. Motion carried w/3 ayes and Council Sitton abstaining.

Minutes of June 8, 2010 Special Meeting were read. Council Finch moved to accept w/ 1 correction. Council Michael Calvert seconded. Motion carried w/3 ayes and Council Sitton abstaining.

(Meeting of June 22, 2010 cancelled due to lack of quorum. )

Minutes of June 24, 2010 Special Meeting were read. Council Michael Calvert moved to accept w/ corrections. Council Finch seconded. Motion carried w/ 3 ayes and Council Sitton abstaining.

Minutes of July 15, 2010 were read. Council Michael Calvert moved to accept w/corrections. Council Finch seconded. Motion carried w/3 ayes and

Council Sitton abstaining.

Financial reports from April through August were read. Council Michael Calvert moved to accept. Council Finch seconded. Motion carried unanimously.

There were no reports of committees. Council Michael Calvert asked about the Park status. Council Finch reported that the park committee would meet in the

near future. Discussion followed about some additional tree removal and whom to hire for this work.

There were no reports of Officers or petitions. No communications to read.

The Mayor asked the clerk to report on some of the steps needed to abolish our old municipal court and move it to the circuit courts of Blount and Jefferson County. The clerk read the proposed ordinance to abolish the Town court. This form was furnished by Mr. Traci Roberts, the Lawyer at the League of Municipalities. (proposed Ordinance 2010-003) Discussion followed about Jail facilities and Police department. After discussion, it was agreed to table for further information and discussion. The Mayor suggested if Council Members have questions to communicate them to the clerk and the clerk would try to research the answers.

Council Finch reported he was sending a letter to Commissioner Pitts concerning the Town's concerns about road work.

The Mayor asked the Council to consider purchasing Quickbooks 2010 to upgrade the trial version of 2007 that the clerk was trying. The price of this software is approximately \$199.00 at Staples. Council Michael Calvert moved we purchase this software with a limit of \$240.00 Council Finch seconded. Motion carried unanimously.

There was no Public Comment.

Council Sitton Moved to adjourn. Motion carried
