Town Council Meeting October 12, 2010

Meeting was Called to order at 7:05PM by Mayor J.L. Calvert .

Roll was Called with Mayor Calvert present. Councils Michael Calvert, Dennis Finch, Pam Sitton, and Herman Mulvehill Present with Council Ralph Calvert absent. A quorum being present, meeting proceeded.
