Minutes Town Council Meeting, January 18, 2011

Meeting was called to order at 7:10PM by Mayor J.L. Calvert.

Roll was called with Mayor Calvert present. Councils present were Dennis Finch, Pam Sitton, and Herman Mulvehill. Absent was Councils Michael Calvert and Ralph Calvert. A Quorum being present, meeting proceeded.

Minutes from December 14, 2010 were read. Council Sitton moved to accept minutes as read, Council Finch seconded. Motion carried unanimously.

Financial Report was read for December, 2010. Council Finch moved to accept, Council Mulvehill seconded. Motion carried unanimously.

There were no reports from committees, reports or reports from officers.

Communications read by the Clerk: invoice from Atty. Prickett was read and Council requested an itemized bill from his office. Invoice from Jefferson Co. Health Dept. advalorem tax was read and authorized to pay. A letter of Resignation from Council Michael Calvert was read by the Clerk.

There were no Petitions.

Under "other Business" Mayor Calvert advised that under the rules, the resolution concerning the amended Solid Waste Management Plan was improperly considered and passed, due to the fact that it was not unanimous, to consider or to pass said resolution, and therefore must be reconsidered at this meeting. Council Sitton moved to set aside the said resolution as improper and have re-read and voted at this meeting. Council Finch seconded. Motion passed unanimously. Resolution to publish Public Notice of this amended Solid Waste Management Plan and have a public Hearing was passed unanimously.

Council Sitton advised Clerk of information on Best Roofing, a company to contact for estimate on roofing work on the Town Hall.

Mayor advised that the meeting time for the public hearing and the final adoption of the Solid Waste Management plan needed to be set. And also the Govt. "Host" meeting had to be scheduled separately. And the meeting for the Solid Waste Manage Plan resolution should be on the next Thursday, January 27, pm 2011. And the Clerk would have the public notice published in the Blount Banner or whoever gave us the best rate.
