Minutes of Host Government Approval Hearing held on June 13, 2011.

Hearing was called to Order at 6:04PM by Mayor J. L. Calvert.

Roll was called. With Mayor Calvert, Councils Norma Holzhauer, Dennis Finch, Pam Sitton, Herman Mulvehill, and Brett Huffstutler, present.

Mayor Calvert opened the hearing stating that this was the Host Government hearing concerning the proposed landfill, and everyone who had signed in to speak would be allowed to speak, and anyone could leave a signed, dated statement also if they so desired.

The Clerk received 33 written statements and or documents pertaining to the proposed landfill during the hearing.

The Mayor asked those who signed to speak to come forward to the podium and speak, that they would be allowed 7 minutes each.

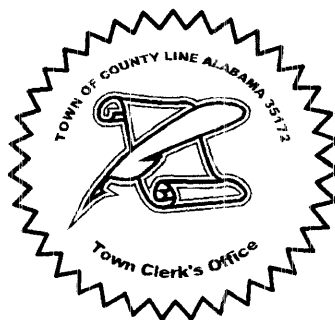

LEGAL NOTICE PUBLISHED IN THE BLOUNT "BANNER HEARLD" NEWSPAPER

REQUEST FOR HOST GOVERNMENT LOCAL APPROVAL FOR PROPOSED MUNICIPAL SOLID WASTE LANDFILL AND PUBLIC HEARING.

On February 17, 2011, Thornhill Marion Properties, LLC, hereafter referred to as: "TMP" requested host government local approval, pursuant to Code of Alabama, 1975, Section 22-27-48, from the Town of County Line, Alabama, 35172, in order for a municipal solid waste landfill to be located, permitted, and operated in incorporated Town of County Line, Alabama. Details regarding the proposed landfill, to include the specific location, are included in the documents that accompanied TMP's request. As proposed, the landfill would accept up to 2,000 tons per day, from a service encompassing Alabama.

The Town of County Line, Alabama has made a preliminary determination, subject to public input, that the proposed landfill is subject to, and consistent with the Town of County Line proposed Solid Waste Management Plan, and solid waste needs as identified in the plan.

The Town of County Line is currently considering TMP's request and will conduct a public hearing to solicit and hear comments from the public. **The hearing will take place in Town of County Line Council chambers at 6:00PM on June 13, 2011 at 6:00PM. The hearing will start at 6:00PM and end at 7:00PM.**

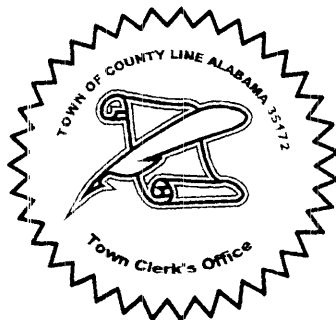




