I. Call to order

II. Roll call

Also there is a problem further down Smith Mill Rd with a sinkhole that needs to be repaired. This is to be tabled until Mayor Self can meet with Mr. Guthrie.

The clerk contacted our County Commissioner Gary Stricklin to set up an appointment with him to see what the county can do to help us. He will be out of town until March 26th he will call the clerk then.

Public discussion on loose gravel on the roads. Lucy Kiley checking the Internet on Government grants websites. Mr. & Mrs. Fields that live on Brandonwood Drive came as spokespersons for annexation into the town. Mayor Self to check on how to handle annexation.

Mr. Joe Knight, Jefferson County Commissioner, spoke to us about some of the problems with Jefferson County and encouraged us to keep working for the good of the people in the town. He thanked us for welcoming him and treating him kindly.
