I. Call to order

Mayor Self read a letter from Jeffco Sheriff's office. It explained the attached check of \$619.38, to the Town of County Line. This money is our share from fees collected when papers are served by the Sheriff's Dept. in Jefferson County.

Mayor Self also discussed a letter from Jeffco EMA. He asked the Council's permission to sign it. This assures us that the Jeffco Roads and Transportation Department will pickup debri from storm damage in our town when needed. The Council was in agreement, the letter was signed.

Mayor Self mentioned adding a couple more fire hydrants in the town, once it is decided where they are needed. A discussion on this will be had at a later meeting.

Myrtle VanKleeck asked if we could hire Tolbert Lawn & Pressure Washing to wash our sidewalk and parking blocks. He offered to do it for \$90,00. Steve Brewer made a motion to do this job and John King seconded. Motion carried.

Scott Mordeci asked the Mayor if the town could change the front door lock to a digital lock. This would make it easier for the Blount and Jefferson County Deputies to access the building for a rest stop. Discussion was had and Mayor Self is to get figures on that. This was tabled for the next month.
