**TOWN OF COUNTY LINE**  
**Regular Meeting**  
**April 8, 2019**

**I. Call to order**

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on April 8, 2019 in the Town Hall. The invocation was given by Don Hagel. The Pledge of Allegiance was recited by all.

**II. Roll call**

The roll call was had. The following persons were present: Mayor Arthur Self, councilor's Myrtle Van Kleeck, Eugene Kiley, Brenda Lowe, John King and Steve Brewer.

**III. Approval of minutes and financials**

The minutes from the March meeting were read. A motion was made by Steve to accept with corrections and seconded by Eugene. Motion carried.

The Financial Reports for March was given. A motion to accept them was made by Brenda and seconded by John King. Motion carried.

**IV. Old Business**

Mayor Self asked the Council if he could have APCO to turn on all of our street lights, once again. Myrtle made a motion to turn on all the street lights and Steve seconded. Motion carried.

We are to re-submit a work order to APCO for repairs needed on streetlights #2,11, and 18.

There is no change in the wire on Ivy Lane.

The storm drain cover on Green Acres Blvd. has been replaced.

No more information on the Lock Box for the back door, at this time.

Mayor Self spoke with someone at the Jefferson County Roads & Transportation Dept. and is being directed to someone else to hopefully get results on repairing the road on Town Street.

Discussion was had concerning the purchasing of a financial CD, The Mayor gave rates from four different local banks. He is to get more information.

The Mayor has called Republic Services concerning the trash blowing off their truck as it goes down our roads. They are to give instructions to their men as how to stop this problem. The Mayor noted to everyone, to please call this company and tell them when you see this happened.

## **V. New Business**

Mayor Self reported that he has hired Attorney Alex Smith, to represent the Town during the Landfill process.

He also reminded the Town Council and Clerk that the annual Statement of Economic Interest must be submitted by the end of April.

It was noted that the upcoming Public Hearing for the R&T Tire Recycling Landfill application, will be held at Love's Crossing Church of God, on April 22, 2019 at 7:00pm. After a short recess, there will be a Special Council meeting to vote on this application!

Mayor Self asked if the Council wanted to "bring back to the table", and discuss raising the "tipping fee" on the Tire Landfill Ordinance. After discussion, Steve made a motion to change the Ordinance, making the tipping fee be Two-Dollars(\$2.00). John seconded. The vote did not carry. 3 Nays 2 Yays
