

TOWN OF COUNTY LINE
Regular Meeting
August 12, 2019

I. Call to order

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on August 12, 2019 in the Town Hall. The invocation was given by Don Hagel. The Pledge of Allegiance was recited by all.

II. Roll call

The roll call was had. The following persons were present: Mayor Arthur Self, councilor's Myrtle Van Kleeck, Eugene Kiley, Brenda Lowe, John King and Steve Brewer.

III. Approval of Minutes and Financials

The Minutes from the July regular meeting were read. Brenda Lowe made the motion to accept them as read. Seconded by Steve Brewer. Motion carried.

The Financials for July were given. Steve Brewer made the motion to accept them as given. Eugene Kiley seconded. Motion carried.

IV. Old Business

1. There is no change on wire hanging at Ivy Lane.
2. Steve Brewer installed a lockbox by the front door of the Town Hall. This was at a cost of only \$34.45.

3. The Mayor is still trying to get someone at Jefferson County Roads & Transportation Dept. to help us with maintaining the JEFFCO streets within the Town limits.

4. Mayor Self had no more information on the CD rates. We may table this and pursue getting a grant.

5. Concerning the storm shelter/multi-purpose building dependent upon the 2020 Census, this could take a couple of years if we qualify. An email was read by the Clerk from Commissioner Knight's office, updating us on the Regular Storm Shelter. Jefferson County Commission Funds have been set aside to cover this type shelter. County Line is on the list to get one!

6. Steve Brewer asked if the 'Moving Blount County Forward' funds could be used for a Safety project. This consisted of purchasing a machine that Checks Speed and reads Tag plates. Discussion was had. No decision was made.

7. Mayor Self instructed the Clerk to ask Tyler Tolbert Landscaping to cut the grass around the Welcome Sign on the East side of Town.

8. Discussion was had about the Business License Late Fees. The Fee Stands.

9. Discussion had concerning a Residential Inspector. Mayor Self suggests we call on Hayden's Residential Inspector.

10. Mayor Self gave the Council a copy of Blount County's Subdivision Regulations to be reviewed. He suggests we adopt this for the Town of County Line. This will be voted on at a later meeting.

11. The Mayor asked for the Council's thoughts on using Attorney Alex Smith as our Town Attorney. Motion was made by Brenda Lowe to ask Attorney Smith to be our attorney. Seconded by John King. Motion carried.

The Clerk was instructed to send a letter to Attorney Greg Reid releasing him from this position.

12. The streetlights were checked by John King and Steve Brewer. Lights #63 and #65 on County Line were found to be out. Also #47 and #21 are flickering on/off.

There was no number on the pole in the curve on County Line Rd. This should be #11. The Clerk will place a repair order according to this report.
