**Regular Meeting**  
**October 14, 2019**

**I. Call to order**

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on Oct. 14, 2019 in the Town Hall. The invocation was given by Myrtle VanKleek. The Pledge of Allegiance was recited by all.

**II. Roll call**

**III. Approval of Minutes and Financials**

2. Mayor Self ask the Clerk to contact APCO and submit a work order on streetlight # 251, that was out.

3. Mayor Self shared with us an update on the FEMA grant paperwork process for the Storm Shelter/Multipurpose Building. He also passed out information including drawings and proposed costs with photos of the building.

4. The Town of County Line was added as a defendant to a law suit brought by ALA WEST,LLC vs Van Mulvehill. Our Attorney will file a dismissal on this.

## **V. New Business**

1. Mayor Self offered a suggestion for Council assignments. This subject was tabled until the next meeting.
2. Mayor Self presented a Resolution for the FEMA Pre-Disaster Mitigation Grant application authorization. Resolution #2019-002, needed to be signed and sent with the application. There was also a letter to authorize Lehe Planning,LLC to prepare the FEMA Pre-Disaster Mitigation Grant. This required signatures of the Mayor and the Clerk. Myrtle Van Kleeck made a motion for the Mayor and Clerk to sign both documents. Eugene Kiley seconded. Motion carried.
3. Myrtle VanKleeck made a suggestion that the Town make a donation to the Underprivileged Kids Christmas Fund. John King made a motion to donate \$500 dollars. Steve Brewer seconded. Motion carried.
4. The Ordinance to adopt Blount County Subdivision Regulations, paperwork was not ready. This was tabled for the next meeting.
5. Mr Curtis asked that we get Blount County to use their Mow/Trim machine on Cobb Brazeel Road.
