I. Call to order

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on Nov. 11, 2019 in the Town Hall. The invocation was given by Myrtle VanKleeck. The Pledge of Allegiance was recited by all.

II. Roll call

III. Approval of Minutes and Financials

IV. Old Business

1. Steve Brewer reported on our streetlights. These lights were out at this time: #65 & #13 on County Line Rd. #30 & #54 on Smith Mill Rd. #45 on Cobb Brazeel Rd. The Clerk was asked to contact APCO. They reported that the repairs on previous lights had been done.

- 2. Mayor Self reported that our FEMA grant application for the Community Safe Room/Multipurpose Bldg. has been submitted to the Alabama Emergency Management Authority for review before forwarding it to FEMA. This was done ahead of our deadline. He noted that a copy of this paperwork has been put on the Clerk's computer, should anyone like to look at it.
- 3. The Town was added as a defendant to a lawsuit brought by ALLWEST,LLC vs Van Mulvehill. Mayor Self shared an updated copy of this suit.
- 4. Mayor Self asked for any volunteers for Council assignments. Roads & Streetlights, were taken by Steve Brewer; Mayor Self will oversee the Storm Shelter process, also communicate with Blount and Jefferson Commissioners; Myrtle VanKleeck agreed to be the contact person for the EMA at Jefferson & Blount Counties.
- 5. Steve Brewer suggested that we donate monies to the Dallas-Selfville Fire Dept. as we did last October. Discussion was had and a motion was made by Eugene Kiley to make a donation of \$2,500.00 to the fire department. Myrtle VanKleeck seconded. Motion carried.
- 6. Mayor Self noted that he was going to contact our attorney concerning the downed cable wires in the town. We need to know our options in removing them.
- 7. The Clerk was asked to call Commissioner Nick Washburn concerning the mow/trim needed on Cobb Brazeel Rd.
- 8. Mayor Self noted that he is working on a Mobile Home & a Subdivision ordinance to be brought up at a later meeting.
