

**TOWN OF COUNTY LINE**  
**Regular Meeting**  
**August 17, 2020**

**I. Call to order**

Mayor Arthur Self called to order the regular meeting of the Council at 7:00 pm on August 17, 2020 in the Town Hall. The invocation was given by Myrtle VanKleeck. The Pledge of Allegiance was recited by all.

**II. Roll call**

The roll call was had. The following persons were present: Mayor Arthur Self, councilor's Myrtle Van Kleeck, Eugene Kiley, Brenda Lowe, and John King. Steve Brewer was absent.

**III. Approval of Minutes and Financials**

The Minutes from the July 13th regular meeting, July 20<sup>th</sup> and July 23<sup>rd</sup> Special meetings were read. Brenda Lowe made the motion to accept as read. Seconded by Eugene Kiley. Motion carried.

The Financials for July were given. John King made the motion to accept them as given. Myrtle VanKleeck seconded. Motion carried.

**IV. Old Business**

1. Cobb Brazeel Road still needs roadwork.

2. Mayor Self shared the information concerning charges for moving and setting up a mobile home in the Town of County Line, at this time are as follows:

Moving Fee	\$75.00
Electrical Connection	\$50.00
Water Connection	\$10.00
Septic Connection	\$10.00

3. Mayor Self clarified that the streetlights are to be paid from the 2 & 7 Road Account.
4. There is no update on the ALA WEST vs. Mulvehill Lawsuit.
5. The Clerk will communicate with the fence company to proceed on installation of our barrier wire.

### **New Business**

1. A proposal was received from Alabama Power to upgrade all County Line streetlights to LED. A motion was made by Brenda Lowe to allow the Mayor to execute this agreement. Myrtle VanKleeck seconded. Motion was unanimous.
2. Mayor Self read an announcement from the Blount County Commission concerning the November elections. The voting precinct at Dallas/Selville Volunteer Fire Station is being moved to Center Springs Baptist Church on Center Springs Road. Notice of this change will be mailed to the precinct voters in the next few weeks.
3. Resolution #2020-003,004,005,006,007,008 were read declaring the person declared in each one duly elected to the office described therein. Mayor Self presented Certificates to each official position.

4. Mayor Self told us the Town is required each year to state it's intentions as to how it will use the funds received from the Rebuild Alabama Motor Fuel Act. He offered up Resolution #2020-009. Eugene Kiley made the motion to accept this resolution as read. Myrtle VanKleeck seconded. Motion was unanimous.
5. There were several public comments concerning the much needed work on Cobb-Brazeel Road. Mayor Self noted that this would be addressed at the September meeting with Commissioner Washburn.
