## **Regular Meeting**

#### February 8, 2021

## I. Call to Order

Mayor Arthur Self called to order the regular meeting of the Council at 7:00pm on February 8, 2021.

## II. Roll Call

The roll call was had. The following persons were present: Mayor Arthur Self, Councilors Myrtle VanKleeck, Eugene Kiley, John King, Brenda Lowe and Steve Brewer.

## III. Approval of Minutes and Financials

The Minutes from the February regular meeting were read. Eugene Kiley made the motion to accept as read. Seconded by Brenda Lowe. Motion carried.

The Financials for February were given. Brenda Lowe made the motion to accept them as given. Steve Brewer seconded. Motion carried.

# IV. Old Business

- Mayor Self is to get with Steve and set up a meeting with Commissioner Washburn about the roadwork needed in the town.
- 2. The Town's Audit is not completed.
- 3. The 2021 year budget is awaiting the results of the Audit.
- 4. The Clerk said that all the annual Ethic Statement of Economic Interest forms are completed .
- Mayor Self commented that the Streaming System has been received. It should be installed and ready to use for the next Council Meeting.

## V. New Business

- Mayor Self shared a Municipal Debris Removal
  Program document from the Alabama League of
  Municipalities. It would require us to pay into the Fund
  and sign a MOU with the plan. A copy was given to the
  Council for review and to be brought up at the next
  meeting.
- 2. It is time to renew the Web Site Name and protection plan. A 3 year renewal costs \$344.58. The option was given to the Council to renew or not. Steve Brewer made the motion to renew and extend the plan for 3 years. John King seconded. Motion carried.
- 3. Mayor Self presented an estimate for electrical repairs to the townhall. These consists of restoring the ground to the electrical panel, replacing our florescent lights with LED, replacing the building sign light with a LED flood light having a day/night sensor. Total for this work is estimated at \$2,425.00. Brenda Lowe made the motion to proceed with the work. Eugene Kiley seconded. Motion carried.
- 4. The Morrison's annexation request has been given to the attorney. We should have paperwork to vote on at the next meeting.
- 5. The Attorney tells us that the Green Acres subdivision covenant is the responsibility of the subdivision contractor and the residents of Green Acres. The Town of County Line is responsible for issuing the building permit and ensuring a structure is constructed in accordance with the Town Building Code.

- 6. A final print of the Mobile Home Ordinance was presented to the Council. This will be tabled till the next meeting so the council has time to read it.
- 7. The Mayor emailed a copy of the Nuisance Ordinance to the Council for review. A work session will be scheduled to specifically address this ordinance.
- 8. Steve Brewer reported that the streetlight update is well under way. It should be completed soon.
